This Privacy Policy constitutes an integral part of the Terms of Use of this website and will be applicable to the personal data provided by the users of the website www.daybat.co.uk to Daybat.

This Privacy Policy is only applicable to the personal data collected through www.daybat.co.uk.

1. WHO IS RESPONSIBLE FOR PROCESSING YOUR DATA?

2. FOR WHAT PURPOSES DO WE PROCESS YOUR PERSONAL DATA?

According to the provisions of the current regulations on data protection, Daybat informs you that it will only process your personal data insofar as they are adequate, relevant and limited to what is strictly necessary for the purposes for which they are collected.

In this regard, you can freely provide your personal data to Daybat through the different procedures established for this purpose, which will process them for the following purposes provided that the User has given his consent in a specific, informed and unequivocal way or that some other legal basis justifies the processing:

- Dealing with information requests, complaints and suggestions through the means that Daybat has available for this purpose. For this purpose, Daybat will be able to process identification and contact data.

- Providing commercial information about Daybat and its services. For this purpose, Daybat may process identification and contact data.
- Providing commercial information from third parties that may be of your interest. For this purpose Daybat may process identification and contact data.
- The management of your subscription to Daybat's newsletter or blog, keeping you informed about news and updates. For this purpose, Daybat may process identification and contact data.

3. WHAT IS THE LEGAL BASIS FOR THE PROCESSING OF YOUR DATA?

The legal basis for the processing of your data by Daybat may consist of:

- The processing is necessary for the performance of a contract to which you are party or in order to take steps at your request prior to entering into a contract.
- The processing is necessary for compliance with a legal obligation to which Daybat is subject.
- Your consent, providing that it has been given by a clear affirmative act establishing a freely given, specific, informed and unambiguous indication of your agreement to the processing of your personal data. You have the right to withdraw your consent at any time.

You state that the personal data you provide to Daybat is true, accurate, complete and up-to-date, as you will be solely responsible for any damage or direct or indirect harm that may be caused as a result of the breach of such obligation.

Likewise, in order to ensure the duty of quality and the keeping of the data up to date, you must inform Daybat of any change that may affect your data.

4. HOW LONG WILL WE KEEP YOUR DATA?

Your personal data may be stored for different periods depending on the purposes for which they were collected:

- Client data: the data will be stored for the time necessary to perform the contract in force. After this period of time, Daybat may store these data for the compliance of legal obligations that require the conservation of such data.
- Data based on consent: the data will be stored from the moment you provide them until you withdraw your consent, through the means that Daybat has made available for this purpose.

5. TO WHICH RECIPIENTS WILL YOUR DATA BE DISCLOSED?

Daybat follows ethical rules and respects your privacy. Except in the case of transfer or disclosure of your data, either in the cases required by Law, or to perform a specific contract, we will not disclose your personal data to third parties without your freely given, specific, informed and unambiguous consent.

For example, Daybat may be required by Law to disclose your data to Public Authorities and other jurisdictional bodies.

We also inform you that third parties may be able to access your personal data on behalf of Daybat, with the only purpose of providing you with the requested services. These third parties will be considered as data processors and implement technical and organisational measures to comply with the regulations in force.

6. WHICH TECHNICAL AND ORGANISATIONAL MEASURES DO WE IMPLEMENT?

In response to our concern for ensuring the security and confidentiality of your data, we inform you that Daybat has implemented the necessary technical and organisational measures against unauthorised or unlawful processing and against accidental loss, destruction or damage of your personal data.

7. WHAT ARE YOUR RIGHTS REGARDING YOUR PERSONAL DATA?

- Right of access: you have the right to obtain confirmation as to whether or not Daybat is processing your personal data and, where that is the case, to access it. You also have the right to obtain a copy of the personal data undergoing processing.
- Right to rectification: you have the right to request the rectification of inaccurate personal data concerning you.
- Right to erasure: you have the right to request the erasure of your personal data, among other reasons, when the data is no longer adequate, necessary or relevant for the purposes for which it was provided.
- Right to object: you have the right to object, on grounds relating to your particular situation, to the processing of your personal data. In this case, Daybat will no longer process such data, unless there are compelling legitimate grounds, or for the establishment, exercise or defence of claims.
- Right to restriction of processing: under the premise that certain conditions are met, you may request the restriction of the processing of your personal data. In this case, Daybat will only process it for the exercise or defence of legal claims, for the protection of the rights of third parties or for reasons of important public interest.
- Right to data portability: you have the right to receive or to transmit to other controllers your personal data in a structured, commonly used and machine-readable format, provided that such processing is based on your consent and is carried out by automated means.

Daybat commits itself to respond to all the requests within the period set out in the regulations in force.

Likewise, you have the right to request a remedy from of the competent data supervisory authority.
